## Service Focus

This months H&I service focus on **Shamia House** a Bi-Bett residential treatment option for Women in Vallejo.

**Bi-Bett** is a California Non-Profit Corporation founded in 1969 which provides Substance Use Disorder (SUD) treatment services in Alameda, Solano and Contra Costa Counties. Bi-Bett plays an important role in the community providing desperately needed treatment services with an array of intensities which include Withdrawal Management (Detox), Residential, Perinatal, Outpatient and DUI outpatient counseling programs. Bi-Bett continues to strive to fulfill its mission: to provide effective and affordable human services to individuals, families and communities with alcohol and drug-related problems in the belief that everyone has value and can grow through change if given one's rightful opportunity to choose. Our goal is to create culturally appropriate alcohol and drug-free environments in which one may experience personal and social growth.

**Shamia House** is a Program for Women including Perinatal Treatment in a residential setting and tailors treatment for pregnant and parenting mothers that are struggling with Substance Use Disorders (SUD). Women in this treatment setting have the flexibility of bringing their children (up to 5 years of age) with them into treatment in order to support the family with a number of real-world life skills such as parenting and coping skills, to name a few. Perinatal residential treatment length of stay varies depending on one's level of functioning and unique needs but can range anywhere from two weeks to 3 months.

# From SHAMIA House Coordinator - Beth

Things are going very well at the Shamia H&I meeting. They are wrapping up some of the construction there so the resident capacity has grown making for larger meetings. We are in good shape for literature with the exception of a couple of things Kimberly is going to be picking up. We have been using the AA book "Living Sober" the last few weeks as a format which the ladies really seem to be enjoying.

Due to the pandemic and closed facilities NorCal H&I has built up a large prudent reserve around \$300K. Note that H&I distributed \$342K in literature for 2022 and is expecting to increase distribution with rising costs and more institutional meetings going live. The past has taught us that it is hard to re-start passing the pink can once it has stopped. It is up to your group to pass the pink can or not. H&I has no opinion on this.
