Will look at again in December. Angela- Move to keep the DBM zoom only. Derek why be opposed? Its hybrid. Angela- my thoughts are that tech issues interfere. I don't plan to attend this meeting in person and I have heard people express really liking the zoom meeting. Sandy- the previous motion in April that was passed to return to in person meetings, we bought a computer, made sure wifi was available, if wifi isn't powerful enough we have allocated to buy a hotspot to make sure in person and hybrid will work out. Since we voted on this in April if we are agreeing to meet in a hybrid format why is a motion being made when a previous motion is being brought up. Angela- the reason why the motion was brought up is because we were having issues finding a venue, then we found a place, my concerns is that we will be having tech issues. I feel that our voices are better heard online. I still think in terms of budget zoom is satisfactory. Any other questions? Terry- I believe we should have zoom only. Sandy- do you have a clarifying question? Terry No. Sandy- This will move to new business next month.

We have to make people excited about it. Sandy- I feel its been challenging to get coverage with service commitments, we struggle, I hear this from area and district as well. What I have heard at area is that hybrid meetings struggle. Currently its been a struggle to how to get zoom meetings to be a participant in the general service conference. Its all over the board and I appreciate you making announcements. My experience is that I get more excited when I am in person and it makes me look at my own recovery. Area does provide hybrid meeting due to the area being so wide, we can reach a larger audience from people with health issues etc. I like meeting in person and get to meet more people who's path that I would not normally cross and provides a deeper sense of community.
