Micheal - It is kind of confusing to me, I was once a DCM and got to vote at both. Now I am a GSR and don't get to vote at area even though I think they should.

a. District 11 has scholarships for PRAASA on a regular basis given the District has the financial means. Included as part of the Budget? Who? Requirement – person in need? How to distribute?

Terry - I think it's a great idea. Our home group has funds in the reserves for such scholarships and don't discriminate on who wants to go since it's against principles to worry about qualifications.

Nell - I think it's a great idea and agree that it is hard to judge who does need it. I suggest a lottery. I don't know if we would even have too many applicants

Sandy - I would like to point out that this is usually a group expense so, this is for groups who cannot afford it.

Micheal - I am in a smaller group that does not have the funds so, I think it would be nice to have been able to go this year.

Melanie - I need clarification on if it is a suggestion or requirement for groups to fund a GSR to PRASAA

Sandy - GSR is a group service position and so should be funded by it. PRASAA is not required but as the coffee maker gets reimbursed for the coffee provided the GSR should be reimbursed for travel expenses.

Melanie - I would love to see more people have the opportunity to attend more assemblies

Duncan - I think instead of calling it a scholarship, call it a subsidy or something so people don't think that it's a full ride. I think we should also put it as a line in the budget.

Jeff - Traditionally it was outside the budget to do this and was considered based on need. Since we are using 7th tradition funds and belongs to everyone, if there were no GSR who wanted to go maybe we could send a non GSR who was interested

Sandy - My first PRASAA the district subsidized \$200 for me to go and it was enough to get me to go which I attribute to my passion for service since.
