Tech/Web Chair - Jeff D: These are two separate jobs, when we made this position we had just gotten into the pandemic and they have each grown substantially. This includes managing the Zoom during the meeting as well as the hybrid equipment being set up for the in person meeting. This takes about ten hours a month. The Web Chair manages the website and is own by GSO. The Web Editor fills in information like distric meeting notes and upcoming events and meeting schedules. This takes about twenty hours a week not including district, officers, and a web committee meetings.

Keep literature in stock such as Big Books, pamphlets, Service Manuals as well as push subscriptions to the Grapevine App and set up the literature table at District and Area meetings. The purpose of this position is to meet persons leaving treatment facilities and getting them to their first AA meeting. There is typically only one interaction but sometimes it turns into more. We give them a ride to the meeting and introduce them to our fellows. We go into Archway as well as Duffy's. We explain who we are as well as give out blue cards that the facilities fill out to coordinate when they will get out of the facility so someone can meet up with them. We also get cards from other districts that we have to hand off to the area where the person will be living afterward if it is not Napa.

# XIV. Amara, DCMC for District 04/Santa Clara North – *Presentation on Safety Workshop* [No visiting Area Officer December]

- Thank you all for letting me be here today (Sharing screen) I am the DCMC for area 04 as well as the. Our responsibility statement is also a pledge which I really, really like. After someone, somewhere has overcome all the odds and has reached out for help, what and who is the hand of AA that reaches back? Is that hand taking advantage of them sexually or financially? Are they not being fully extended because of social status or color of their skin? If I am responsible, what do I need to do? What resources are available? There is a pamphlet "The AA member - Medications & Other Drugs", the yellow safety card provided by GSO. Anonymity is not a cloak for illegal or illicit behavior, individuals are still subject to the law and authorities can be called. "Membership does not include having to tolerate sexual harassment, threats..." From the Service Manual, Talk about issues of safety before they arise at the group level. Let AA members know that if they are concerned about the words or actions of another member, let another trusted member know. It's okay to talk about it. If someone comes to you with a concern, how would you respond? Our safety committee is wondering how to create guidelines. We are having a Safety in AA Forum on October 19, it will be hybrid. district04cnca.org if you want to help please browse our website and complete our safety survey. Register so we know you are coming. We will have international visitors as well as people from GSO.
- Joe: My home group we had some issues coming out of covid with women feeling uncomfortable. We had our DCM come in and we had some meetings about it and decided to read the predatory behavior part of the safety card. Now that safety positions have rotated and people are not used to the issues I wonder if there is a more general way to say this.
- Amara: Thank you for sharing because we are looking for specific instances. We will be providing a safety toolkit at the workshop to provide examples of general statements to bring back to your groups. You might consider looking at having a more broad statement like, knowing that it is okay to speak up but also have actions to take as a group when someone does speak up.
- Angela: I have never heard of the yellow card or the safety flier. Since a lot of my friends in the room have a lot of sobriety and have an unspoken understanding, I know that those who need help because of their behavior are the people who often need the meeting the most. It is hard to find this balance of policing and being welcoming.

Amara: Why do we allow the disruptors to stay, for example men, and send their victims to womens meetings instead of the other way around?
