The table of contents is very useful as it has all of the motions that were discussed and voted on. These are all advisory actions as they do not have the legal power to make the board do anything but, the board has always followed suggestions. What are additional committee considerations? The meeting starts with each committee meeting with themselves to discuss motions that have been brought up and decide how and if they get brought to the conference. Some motions end at this meeting, such as the asian american pamphlet this year. It got brought up as a floor action which are motions that come up on the fly or get used to revive things that have only made it to the committee. A lot of people like the graphs for sales and contributions to check that AA is financially healthy. I like to read the keynote address as it does a nice summary of what happened this year in AA and what the general feel of what is going on at the conference. You can of course read it front to back but, I like to pop around and read only what is pertinent to my and my group's interests. I think there is a value in not being the best GSR in the world and just giving the most adequate service and in so doing "just get the job done" as the fear of making mistakes stops us from doing the job. In this case I would hold up this report and tell them that it has a summary of everything that happened at the conference and is available for reference. If you try to deluge your group with too much info you might find that they vote to stop having GSR reports. I love being able to look back to reports in the past because it enables us to learn what has happened and what we have tried to do in the past, overcoming obstacles.

Jeff - Thank you for being so adequate! In my experience, the group wants to know specifically what happened to the thing we voted on and that info can be hard to find

Jackie - If you go to cnca06.org or ask your DCMC what happened. I don't think this report is written for the average AA to understand what is going on and that is why we have a delegate and other general service people to read, understand and explain to their groups. There is also too much information that comes down from this conference and this report has literally everything that happens and is honestly too much so, it the the right and responsibility for the delegate, DCMC, and GSR's to filter out what needs to be passed on.
