9. Financial Oversight Committee Update: Jason A. (Presentation of 2026 Budget) - Jason updated some of the amounts based on actual expenditures. Duncan put together a spreadsheet when he had the position. Look at what our hard costs vs discretionary costs are. Make it easier for Meaghan to approve expenditures with the budget. Discretionary needs to be approved by us in a housekeeping motion. Do we want to make a donation to the church in lieu of paying rent to them? The large cost is \$1500 for unity day. We're running on a negative budget. Duncan says it is not uncommon for us in the past to run a deficit budget. Our income is all based on donations. Jason is going to send out a budget and we will have a month to review it and then decide if we want to move forward or postpone.

10.DCMC Report: Duncan L. - WE DID SO GOOD LAST MONTH. Everything we did for the assembly and for joining in with the Halloween party and doing an inventory. Thank you all for everything that you do for this group. I want everyone to come to more ACM events.

12. Visiting Area Officer: Claudia N. – CNCA 06 – Alternate Delegate

a. Budget...how do we do that? - There was already a budget in place and we had oversight for transparency. Where our numbers were at and where assemblies are going to be. Communication and transparency. We establish a prudent reserve. We go over the new budget in January and we have a certain percentage of what our prudent reserve is so we adjust it. We presented a draft budget. We have all the subcommittees and we create budget worksheets. Then we put the past year budget and what the actual was. So we always have the history to look back on. "Do you foresee any future needs that are not addressed in your budget" We help people stay as close as they can to a good time line for getting their financial needs met by the area. We try and be reasonable and meet our peoples needs. The guidelines are guidelines, but we try and stick by them. A budget is a financial plan. As long as we always

keep in mind that it's the fellowship's budget and no one takes ownership of it then we can always work it out. This is our 12 step work. Always ask the question if you really need the information. Encourage you to have a voice and call someone before and make sure that you feel like you have enough information.

Meaghan- How do you make the reimbursements more attractive and we're budgeting correctly for what it actually would cost us to run our district. Claudia- We have forms that are emailed and their fillable PDF's. You can always contribute the reimbursement back if you don't want the reimbursement. Changed guidelines from 90 days to 60 days. Reimburses with Zelle. Used to write checks on checks and scan receipts.

Jason- Can you elaborate on the changing of the prudent reserve. Duncan- changed our prudent reserve from \$800 to \$3000, because it has been \$800 for 6 panels. Is there guidelines around months of expenditure that it should be? Duncan based on the 6 months of prudent reserve because that's what the board puts out for AA as a whole and we were figuring our expenses were between \$6-\$10,000. Claudia says one month's operating expense and divides the budget by 12 so our budget changes every year what is coming in and what is going out so we change it every year.

Michael-I try to avoid the job of treasure. Is it a good idea if you don't have any experience with money or numbers to avoid the job. Claudia says you can make yourself available in any position and the fellowship will decide. She learned on the job.
